PRIVACY ACT STATEMENT

AUTHORITY: AFI 13-204V3, 124 FWI 13-204, Flight Information Publication IFR Supplement and the AP1
 PURPOSE: To provide information in determining airfield/ramp/support availability, flight following & traffic flow
 DISCLOSURE: Voluntary, however if not provided you will not be granted a PPR
 ROUTINE USES: All Military Aircraft arriving in Boise, ID are required to submit a PPR prior to arrival

SECTION I - NOISE ABATEMENT PROCEDURES

- *Strict compliance is **MANDATORY**
- *MAX PERFORMANCE CLIMBS NOT AUTHORIZED
- *STRAIGHT-IN FULL STOP ONLY for all transient aircraft
- *ON DEPARTURE, expedite climb to 5000' MSL unless directed otherwise by ATC
- *FIGHTER AIRCRAFT will request the south runway (10R/28L) with ground when departing
- *OVERHEAD TRAFFIC PATTERNS NOT AUTHORIZED except to permanently assigned aircraft
- *AFTERBURNER takeoffs/go-arounds/missed approaches RESTRICTED to OPERATIONAL REQUIREMENT ONLY
- *QUIET HOURS in effect for fighter aircraft 0200-1400Z++ (1900-0700L): No take-offs/landings/engine runs w/o 124OG approval
